Duties:

- Assist in installation and maintenance equipment within the Gas Turbine (GT) power plant.
- Responsible for operation and monitoring of the GT power plant.
- Ensure GT is brought online as requested by the National Electricity Supply Control Centre (NESCC) and ensure compliance to all operating policy, procedure, and instructions during the operations of generating and auxiliary plant equipment.
- Efficiently troubleshoot, diagnose, repair and report simple faults.
- Responsible for the proper use of vehicle and other equipment and adhere to traffic laws and company policy.
- Responsible for monitoring the key performance indicators of all operating equipment to ensure efficient operations and to take immediate action to safeguard the equipment from potential damage, where warranted.
- Be knowledgeable of all maintenance instructions, diagrams, spare parts, and operation of all plant equipment.
- Perform on-call duties on a rotational basis and respond to emergencies.
- Responsible for receipt, and verification of fuel, lubricating oil and the preparation of relevant reports.
